BID SUBMISSIONS

Bids shall be made on the Proposal forms furnished with the Specifications, and must be accompanied by a Bid Bond acceptable by the YHFD, in the amount of not less than 5% of the total amount of the Bid. Bidders who submit certified checks must accompany them with a Consent of Surety from a recognized Bonding Company. Checks shall be made payable to the YHFD and are to be held by the YHFD as a guarantee for the proper execution and delivery of the Contract and bonds to secure the faithful performance thereof. In default of such execution and delivery of Contract and Bonds, the amount of the deposit represented by the check shall be forfeited and retained by the YHFD as liquidated damages. No Bidder shall withdraw his bid within forty five days (45) after the formal opening thereof.

The YHFD reserves the right to waive any informalities, in their discretion, in any proposals, and to award contracts in a manner deemed to be in the best interests of the YHFD and in accordance with the law, even if such award is to other than the lowest bidder. The YHFD reserves the right to reject any or all proposals and to advertise for new proposals. The accepted low bidder(s) will be required to furnish a 100% Performance Bond and a 100% Labor and Material Payment Bond. All bids must contain a signed affirmation of non-collusion, included in the Bid Proposal Form, as per Section 103-d of the New York State General Municipal Law.
